### **CONDITIONS**

1. USTA and ORC Rules to govern. Negative Coggins test required. LIMITED STABLING.
2. Entry fee \$30 (includes 2 passes to fair). OVERNIGHT event only.
3. Any horse declared must pay entrance fee.
4. **Lasix will be responsibility of the trainer or owners of each horse.**
5. Purse money may be withheld pending return of state lab test & **owners tax information.**
6. **Gray Division - Starting Fee: \$250.**
7. Speed Committee reserves the right to declare off or change program if conditions warrant.
8. The Cuyahoga County Agricultural Society assumes no responsibility or liability for any accident to persons, horses, or property.
9. If more than 1 division, each division will race 1 heat, purse to be split evenly. Trophy to fastest heat. Track will score 5 wide.
10. Money divided per Ohio Fair Racing Conference rules. No more monies will be paid than there are starters in any overnight event.
11. **STARTING FEE & OWNER'S SOCIAL SECURITY NO.S MUST BE IN RACE OFFICE 1 HOUR PRIOR TO POST TIME.**
12. **Any check returned will be charged a \$50 NSF fee.**
13. ALL STAKES RACES will be raced according to Ohio Fair Racing Conference Conditions.
