Rules & Regulations

All vendors for the 2021 Cuyahoga County Fairgrounds Queen of Hearts Craft Show are required to read the Rules and Regulations governing the event and the COVID Rules and Waiver form, and acknowledge they have done so by having a signed copy of the rules on file:

- Be Present hours of operation Saturday February 13th from 9am-3pm. No early tear downs.
- No part of booth or display may extend out into the aisle
- Only Blue or Green Painters Tape may be used on walls
- Leave space clean. No trash or unwanted items may be dumped or left behind. Trash cans are only for personal items such as coffee cups, food wrappers, etc. (Cardboard can be flattened and left at entrance)
- Sale or swap of explosives, flammables, alcoholic beverages, animals, obscene materials, or illegal items is prohibited. Containers or items that contained gas are not allowed in buildings
- Cords cannot be laid across aisles
- No loud music as determined by Market Staff
- No Parking in front of building during show hours
 - Vehicles must be moved after unloading, be considerate
 - All parking is to be in designated areas
- **SET UP**
 - No Setting up until payment is processed and rules are signed
 - **Set up is Friday evening 5pm-7:00pm**
 - Additional setup time Saturday morning 7:00am-8:45am, Sunday
 - Please call if unforeseen circumstances arise
 - Space to be vacated by 4:30 pm Saturday

Management's interpretation and execution of the above Rules and Regulations is final.

Reasonable care and protection is given to property and people on our premises. Market staff is not responsible for injuries caused by others or injury to persons entering these premises. Also, no responsibility is assumed for any damage or loss due to fire, theft, breakage, or collision. Articles are conveyed to the market and displayed and sold at owner's risk.

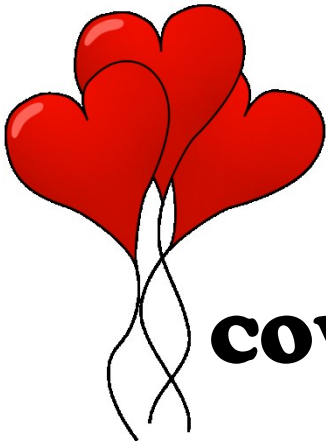

COVID-19 Safety Acknowledgment Liability Waiver and Release of Claims

COVID-19 SAFETY INFORMATION:

While participating in events held or sponsored by the Cuyahoga County Agricultural Society, ("CCAS") "social distancing" must be practiced and face coverings worn at all times indoors to reduce the risks of exposure to COVID-19. Because COVID-19 is extremely contagious and is spread mainly from person-to-person contact, CCAS has put in place preventative measures to reduce the spread of COVID-19. However, CCAS cannot guarantee that its participants, volunteers, partners, or others in attendance will not become infected with COVID-19.

In light of the ongoing spread of COVID-19, individuals who fall within any of the categories below should not engage in CCAS events. By attending a CCAS event, you certify that you do not fall into any of the following categories:

1. Individuals who currently or within the past fourteen (14) days have experienced any symptoms associated with COVID-19, which include fever, cough, and shortness of breath among others;
2. Individuals who have traveled at any point in the past fourteen (14) days either internationally or to a community in the U.S. that has experienced or is experiencing sustained community spread of COVID-19; or
3. Individuals who believe that they may have been exposed to a confirmed or suspected case of COVID-19 or have been diagnosed with COVID-19 and are not yet cleared as non-contagious by state or local public health authorities or the health care team responsible for their treatment.

DUTY TO SELF-MONITOR:

Participants agree to self-monitor for signs and symptoms of COVID-19 (symptoms typically include fever, cough, and shortness of breath)

LIABILITY WAIVER AND RELEASE OF CLAIMS:

I acknowledge that I derive personal benefit by virtue of my participation with CCAS, and I willingly engage in CCAS events.

RELEASE AND WAIVER.

I HEREBY RELEASE, WAIVE AND FOREVER DISCHARGE ANY AND ALL LIABILITY, CLAIMS, AND DEMANDS OF WHATEVER KIND OR NATURE AGAINST THE CUYAHOGA COUNTY AGRICULTURAL SOCIETY, INCLUDING IN EACH CASE, WITHOUT LIMITATION, THEIR DIRECTORS, OFFICERS, EMPLOYEES, AND AGENTS (THE "RELEASED PARTIES"), EITHER IN LAW OR IN EQUITY, TO THE FULLEST EXTENT PERMISSIBLE BY LAW, INCLUDING BUT NOT LIMITED TO DAMAGES OR LOSSES CAUSED BY THE NEGLIGENCE, FAULT OR CONDUCT OF ANY KIND ON THE PART OF THE RELEASED PARTIES, INCLUDING BUT NOT LIMITED TO DEATH, BODILY INJURY, ILLNESS, ECONOMIC LOSS OR OUT OF POCKET EXPENSES, OR LOSS OR DAMAGE TO PROPERTY, WHICH I, MY HEIRS, ASSIGNEES, NEXT OF KIN AND/OR LEGALLY APPOINTED OR DESIGNATED REPRESENTATIVES, MAY HAVE OR WHICH MAY HEREINAFTER ACCRUE ON MY BEHALF, WHICH ARISE OR MAY HEREAFTER ARISE FROM MY PARTICIPATION WITH THE EVENT.
