CCAS CAMPGROUND RULES

- You must be eighteen (18) years of age or older to reserve a campsite in your name, campsites cannot be subleased.
- All trailers, campers, trucks or other vehicles used for living purposes must be parked in designated areas only.
- All pets/animals kept in campgrounds MUST BE ON LEASH AND CONTROLLED AT ALL TIMES.** Registered campers are responsible for any injury or damage.
- All waste is to be placed in containers provided or designated areas only. No waste of any kind to be left in campgrounds. Dumping of holding tanks is prohibited. All premises around campsites are to be kept clean and sanitary.
- Electric hook-ups are to be proper receptacles only and one camping unit per hook-ups. All hook-ups and receptacles must meet CCAS standards and local Fire Department inspection.
- Fresh water and waste water hook-ups must use approved hoses.
- NO OPEN FIRES OR FIREWORKS PERMITTED.**
- Alcoholic beverages are restricted to campground units only.
- CCAS ENFORCES NOISE CURFEW AFTER MIDNIGHT.**
- FAILURE TO COMPLY WITH ANY OR ALL OF THE ABOVE RULES OR REGULATIONS WILL RESULT IN FORFEIT OF CAMPING FEES PAID AND REMOVAL OF CAMPING VEHICLES FROM GROUNDS AT OWNERS EXPENSE.
